Dear current Year 5 Parents and Carers,

We are delighted to share with you that when your child joins us in Year 6 we are able to offer them the opportunity to take part in a 3 day/2 night residential stay at Hooke Court, Dorset, from Wednesday 8th to Friday 10th November 2023.

What's it all about?

As a school, we have been looking for different opportunities and experiences that our children can have at Hiltingbury during their residential stays. Hooke Court offers immersive learning opportunities, which are a truly unique experience. Alongside plenty of team-building fun, our visit will enrich our WWII curriculum in a way we could never achieve in the classroom! As part of their stay at Hooke Court, our Year 6 children will take part in a WWII day, which includes everything from drama, shelter building, cooking, VE day celebrations and a campfire. On the journey home, we will also be taking a trip to Bovington Tank museum to further enrich the children's historical understanding.

What does it cost?

The cost per person is approximately **£190** and can be paid in instalments. Please note that this is based on 96 children attending and if less than this attend, the price may increase slightly. We will be able to confirm the final price in September.

The cost includes:

- Return coach travel from school
- A full daily programme of activities
- Trip to Bovington Tank Museum
- Meals and accommodation

What do I need to do next?

If you would like to reserve a place for your child, please log in to your Arbor account, review the consent and agree, then make the deposit payment of **£20 by Friday 14th July**.

All payments must be made via your child's Arbor account. Please note that once payments have been made as set out in the payment schedule below, they are not refundable subject to the terms and conditions set out by Hooke Court.

Payment Schedule

- £20 by Friday 14th July
- £80 by 8th September
- Final balance by 8th October

Alternatively, following the initial payment of the deposit, you can pay weekly / regular instalments. In the event of cancellation any monies paid exceeding the payment schedule would be refunded.

For families that are entitled to free school meals a percentage subsidy will be made in relation to the cost of the trip. After the £20 deposit has been received we will contact eligible families with further information. For more information please see our [Charging & Remissions Policy](#).

In the event of cancellation by the centre, the trip will either, where possible, be postponed and re-arranged or a refund made less the non-refundable £20 deposit. Hooke Court's full terms and conditions are available upon request via the School office.
